Korea New Zealand Business Forum

An afternoon conference on 3 March on the further development of trade between Korea and New Zealand, with top business speakers from each country, followed by the President's address, his only one to a business audience during his Official Visit to New Zealand. The President will speak at approximately 5.00 p.m.

A reception will follow.

A 10 -15 strong senior business delegation will accompany the President on this visit to New Zealand, and will attend this business council meeting.

- Presentations from the Korean side will include an address by the President of the Korean Institute for International Economic Policy on Korea's economy and prospects for a Korea/NZ FTA, and one on Korea's information technology vision.
- While not all details are confirmed yet, we hope that from the New Zealand side there will be presentations on information technology, education services and infrastructure development.
- Senior Korean business persons attending will include the Chairman of the Korean Chambers of Commerce and Industry, the Chairman of the Federation of Korean Industry, the President of the Hyundai-Kia Group, the Chairman of DK Korea, the Chairman of the Korean Importers' Association, and the President of the Korean Institute for International Economic Policy. Other companies will be represented.
